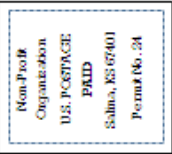
John Hultgren is the director of Dickinson County Health and EMS in Abilene, KS. He received his paramedic education from Barton County Community College.

Lenworth M. Jacobs, MD, MPH, DSc (Hon), FACS, FWACS (Hon) is the Director of the Trauma Institute at Hartford Hospital. He is Professor of Surgery and Professor of Traumatology and Emergency Medicine at the University of Connecticut. He graduated from the University of the West Indies Medical School in 1970. He received his surgical training at the Peter Bent Brigham Hospital in Boston and at University and Boston City Hospitals. He received a Master's in Public Health from the Harvard School of Public Health. Dr. Jacobs became the Director of Emergency Medical Services for the City of Boston and the Trauma Center at Boston City Hospital. He designed and implemented the Basic and Advanced Life Support Prehospital Service for the City of Boston. He then moved to Hartford Hospital where he implemented the LIFE STAR Air Medical Service and the Trauma Center. He inaugurated a new Department of Traumatology and Emergency Medicine at the University of Connecticut School of Medicine. He is the founder of the Advanced Trauma Operative Management Course (ATOM) and the Editor of the ATOM Textbook. His work with the mass shooting at Sandy Hook led him to work to develop the national call to action campaign "STOP the Bleed".

Kenneth Marshall, MD is an assistant professor of emergency medicine at the University of Kansas Health System. He earned degrees in medicine and biomedical ethics from Georgetown University, and served as a research intern for President Bush's Council on Bioethics. He completed his residency in emergency medicine at the Harvard-Affiliated Emergency Medicine Residency at Beth Israel Deaconess Medical Center. During residency, he was the senior resident in the emergency department at Beth Israel Deaconess Medical Center during the Boston Marathon Bombing. Since that experience, he has had a focus on mass casualty responses, working within the emergency department and hospital to provide workshops on multi-casualty triage, decontamination, and patient flow in surge situations, and has lectured on mass casualty medicine and disaster response.

Kerry McCue is the Ellis County Health Services Administrator. He received his certification as an emergency mobile intensive care technician from the University of Kansas Medical Center, a BS in Health Care Administration from the University of Kansas, and a Masters of Public Administration from UMKC.

Frank Zilm, D. Arch is the Chester Dean director of the Institute for Health and Wellness Design at the University of Kansas School of Architecture and Design. Frank has developed unique analytical approaches to the estimation of emergency department treatment space requirements and simulation modeling tools to test future space needs. Over the past 40 years he has been directly responsible for the planning and space programming of over 67 emergency departments, most recently (2016) for the replacement hospital at Saint Louis University and for Mercy Health in St. Louis (2019). Frank was a consultant to the Office of Homeland Security EROne study and applied many of the recommendations of that research to the planning of Tampa General Hospital.
